As State agencies expand their emphasis on improving educational results and functional outcomes for children and youth with disabilities, they must also expand their understanding and use of data. It is not enough to use a single metric at one point in time to determine whether improvement is occurring. State agencies must increase the capacity of their own personnel, while also finding ways to increase the capacity of local agencies to effectively examine a variety of data on activities, fidelity, and effect of improvement efforts. Additionally, both State and local agencies must identify measures that will remain stable enough over time to make comparisons and draw conclusions. The Minnesota Department of Education (MDE) chose increasing the six-year Statewide graduation rate of American-Indian and African-American students with disabilities as their State-identified measurable result (SIMR), following data and infrastructure analyses and stakeholder input. An Innovative Funding Structure for Social Programs: Pay for Success

Pay for Success (PFS) is an innovative funding model used to address complex social problems. In a typical PFS Financing model, private investors finance the cost of operating a promising or proven social program that has the potential to save the government money in the long term. The government only pays back the initial investment, plus a return on investment if specific, agreed-upon outcomes are achieved. Over 40 PFS projects are currently being implemented or planned nationwide to address critical needs in the areas of health, justice, labor, and early education. The number of projects and the amount of private investment in social programs is expected to grow in the coming years. What's New With Gathering and Using General Supervision Data in Results-Driven Accountability

Let's Stop Kicking Children of Color Out of Preschool!

Preschool children are expelled from school three times more than all children from Kindergarten through Grade 12. The U.S. Department of Education found that African-American children make up only 18 percent of the preschool population, but account for close to 50 percent of all suspensions. American-Indian and Native Alaskan children make up less than 1 percent of the population but account for 2 percent of suspensions and expulsions. Culturally responsive practices show the most promise for reducing these disparities. During this roundtable, there will be robust discussions about (a) implicit bias, (b) addressing and acknowledging personal biases, (c) connecting with children and families, and (d) creating a culturally responsive environment. The Double-Check Cultural Framework will be presented as a tool for practitioners and supervisors to evaluate the implementation of culturally responsive strategies in early childhood programs.

How to Win Friends in an Integrated Data World

A Journey Begins With a Single Step: Engaging Families to Improve Child and Family Outcomes

This session will share effective family engagement practices in Indiana and Montana First Steps. Indiana's Part C program has found it challenging to engage families in poverty and families of African-American descent. As a result, Indiana has focused its State Systemic Improvement Plan (SSIP) process on improving engagement with these families. Data from phone interviews with families and providers, as well as a new observational coding system and a new family assessment tool, will be introduced. Montana successfully implemented the Routines-Based Interview™ (RBI™) throughout all early intervention provider agencies as their family information-gathering tool through the creation of MT RBI™ Boot Camps held around the State—an effective implementation model that bridges the gap between science and practice. Discussion will focus on improving family engagement practices using multiple methods across multiple domains, and will encourage the sharing of information among participants about what is happening in other States.
